Dear Brigadier General Hagan:

In accordance with Section 5.c. and 15.c of General Order No. 58-A, Standards for Gas Service in the State of California, PG&E respectfully submits notification of changes to its Gas Meter Test Equipment. PG&E's Gas and Electric Meter Services facility (GEMS) is located at:

42100 Boyce Rd. Fremont, CA 94538

This letter serves as PG&E's notification to the Commission that the plans submitted on June 20, 2012 (attached) have been implemented and all three phases of the work completed. Also attached is an updated list of PG&E's meter testing equipment.

Phase 1: Completed (6-14-2012)

- Remove one 10-cubic-foot bell prover (maker's number 1249) from service.
- Remove one 20-cubic-foot bell prover (maker's number 1249) from service.
- Move an existing American Series III Universal Sonic Nozzle Auto Prover (SNAP), serial number 040805-051 into the location vacated by the 10- and 20-cubic-foot bell provers.

Phase 2: Completed (2-15-2013)

- Retirement and decommissioning of six (6) 5-cubic-foot bell provers and replacement with three new American Meter SNAP MMX-PG&E Sonic Nozzle Provers.
- Decommissioned bell prover maker's numbers: 2043, 1175, 1955, 1959, 1500, 1944
- Installed SNAP serial numbers: X1212-062, X1212-063, X1212-064. These SNAP's reside in room 126.

• Retention of one 5-cubic-foot bell prover, maker's number 1955, to be utilized as a Master Reference Bell Prover for the meter plant's Sonic Nozzle Proving equipment. This Master Reference Bell prover resides in room 126.

Phase 3: Completed (12-20-2013)

- Retirement and decommissioning of thirty six (36) 5-cubic-foot bell provers and replacement with sixteen (16) new Elster-American Meter SNAP MMX-PG&E Sonic Nozzle Provers and one (1) SNAP MMX-Series III Sonic Nozzle Prover.
- Decommissioned bell prover maker's numbers: 1968, 1108, 1165, 2033, 1635, 1354, 1837, 1701, 3532, 1478, 1148, 3497, 1277, 3496, 2265, 1112, 1433, 1521, 1275, 1379, 1059, 1060, 1380, 1276, 1504, 2078, 2146,, 1260, 1261, 1329, 1943, 1085, 1012, 579, 456, 321

- Installed SNAP MMX-III serial number: X1013-090. This SNAP resides in room 161.
- Retirement and decommissioning of a 5-cubic-foot Master Reference Bell prover with maker's number 2262.
- Retirement and decommissioning of a 5-cubic-foot Master Reference Bell prover with maker's number 1955.
- Retention of one 5-cubic-foot bell prover, maker's number 1060, to be utilized as a Master Reference Bell Prover for the meter plant's Sonic Nozzle Proving equipment. This Master Reference Bell prover resides in room 165.
