ADVICE LETTER 2258-G (U 902-G)

PUBLIC UTILITIES COMMISSION OF THE STATE OF CALIFORNIA

SUBJECT: CONSOLIDATED GAS RATE CHANGES EFFECTIVE JANUARY 1, 2014

San Diego Gas & Electric Company (SDG&E) hereby submits, for California Public Utilities Commission (Commission) approval, the following changes to its gas tariffs, shown in Attachment B.

PURPOSE

The purpose of this filing is to consolidate several previously filed advice letters and Commission decisions that reflect gas rate changes. This results in \$8.2 million decrease, with Franchise Fees and Uncollectibles (FF&U) in SDG&E's gas transportation (non-commodity) revenue requirement for core customers as well as a \$4.7 million decrease for noncore customers, resulting in a total net decrease of \$12.9 million (4.0%), with FF&U, effective January 1, 2014, as reflected in Attachment A. This decrease represents the gas rate adjustments requested by compliance Advice Letters (AL) 2228-G and 2237-G; Decisions (D.) 09-11-006 and D.13-05-010.

In addition, this filing reflects increased gas transportation costs allocated from Southern California Gas Company (SoCalGas) to SDG&E as reflected in SoCalGas' consolidated rate update AL 4586, dated December 27, 2013.

DISCUSSION

2011 Energy Efficiency Incentive Awards

Pursuant to D.12-12-032, SDG&E filed AL 2228-G¹ on September 26, 2013, requesting its program year 2011 Energy Efficiency (EE) incentive awards. Pursuant to Resolution G-3491, SDG&E was authorized an award of \$0.781 million, without FF&U, effective January 1, 2014. This results in the Rewards and Penalties Balancing Account (RPBA) amortization of \$0.564 million, without FF&U.

Annual Regulatory Account Balance Update

SDG&E filed AL 2237-G² on October 29, 2013 to revise its gas transportation rates. The revisions to these gas rates resulted from an update of two key cost components: 1) amortization of gas regulatory account balances, and 2) the SoCalGas transportation costs allocated to SDG&E pursuant to SoCalGas' authorized regulatory accounts update. Overall, the net effect of this filing is an annual gas transportation revenue requirement decrease of \$20.8 million, without FF&U, effective January 1, 2014.

Storage Costs for 2014

Pursuant to the 2009 Biennial Cost Allocation Proceeding (BCAP), D.09-11-006, the Commission authorized SDG&E to update its storage revenue requirement annually based on the flow-through from SoCalGas. This result is a \$0.178 million, without FF&U, increase in the revenue requirement effective January 1, 2014.

SDG&E 2012 General Rate Case (GRC) Post-Test Year Attrition

SDG&E is implementing its 2014 post-test year attrition adjustment of 2.75%, or \$7.8 million, without FF&U, as authorized in D.13-05-010³, effective January 1. 2014.

SoCalGas' Costs

On December 27, 2013, SoCalGas filed its consolidated rate update (AL 4586) which increases the gas transportation costs allocated from SoCalGas to SDG&E. The SoCalGas pass through transportation cost component of SDG&E's gas revenue requirement increased by \$0.066 million, with FF&U. Also included in the total SoCalGas costs for this filing is an increase of \$0.005 million, with FF&U, for other pass through costs. The revenue requirement below also includes a Semprawide EG adjustment for an increase of \$0.030 million, with FF&U, and a decrease in the system integration adjustment of \$0.364 million, with FF&U. All rate changes are filed to be effective concurrently with the SoCalGas consolidated gas transportation rates to equalize the Sempra-wide EG rate effective January 1, 2014.

By this filing, SDG&E implements the above-described changes commencing January 1, 2014, which results in a decrease of \$13.0 million (4.0%) for SDG&E's consolidated non-commodity system average gas transportation rates.

III. COST ALLOCATION AND REVENUE REQUIREMENT

REVENUE REQUIREMENT D.

The Revenue Requirement shall be the sum of all costs estimated to be incurred by the utility for providing gas service to utility customers during the forecast period. Utility rates and the allocation of gas service costs to customers shall be established in such a manner as approved by the Commission to recover the costs specified below:

1. Procurement Revenue Requirement

Transportation Revenue Requirement 2.

The Gas Base Margin amount shall be the total annual base revenues authorized by the Commission. The authorized gas margin pursuant to SDG&E Advice Letter 2258-G, effective January 1, 2014, is \$298,243,000. This Gas Base Margin represents the total revenue requirement less miscellaneous revenues and is adjusted for transmission system integration and backbone transmission service; plus

- b. A forecast of California Alternate Rates for Energy (CARE) program costs, which reflect the costs associated with providing a 20% CARE discount to residential gas users who meet certain criteria; plus
- The amortization of utility gas balancing accounts, which reflect an under- or over-C. recovery of nongas costs authorized for recovery by the Commission prior to the forecast period. These account balances include but are not limited to:
 - Core Fixed Cost Account (CFCA); (1)
 - (2)Noncore Fixed Cost Account (NFCA):
 - Rewards and Penalties Balancing Account (RPBA); (3)
 - (4)Self-Generation Program Memorandum Account (SGPMA);
 - (5)Hazardous Substance Cleanup Cost Account (HSCCA);
 - Integrated Transmission Balancing Account (ITBA) and (6)
 - Any other account authorized by the Commission granting full recovery of (7)specific costs.


