We have no problem canceling the meeting, but just wanted to ensure you didn't have any questions or concerns about the CAISO's November 6 performance audit notice. Since the CAISO's notice was issued, there have been a few new developments. First, the CAISO has rescinded 3 of the 5 performance audit failure notices because of errors in their analysis. Second, they have informed us that the claw back for ancillary services payments made for those resources will be \$69.50. Pretty minor, to say the least.
