Hi Eric,

So Cal Gas has reported to the CPUC that, in addition to some localities' having passed measures purporting to bar the installation of smart meters and/or related equipment such as data collection units, some local government agencies have withheld ordinarily available permits to install such equipment in public and/or private areas (e.g., on an existing power or

light pole).

Has PG&E had such issues? I recall one relatively public incident in which maybe the town of Fairfax passed a “no smart meters” regulation that threatened to fine or criminally prosecute PG&E employees who installed AMI equipment. My understanding was that y’all came to an understanding with the locality so that they backed down on actually enforcing the regulation. Have there been other attempts to actually implement such purported bans on AMI installation and/or withholding of permits for such installation?

If you don’t know, can you point me towards who might?
