Provided updated presentation and began discussion:

- Provided details to 6 indications found by Leak Survey for the 600 miles
  - Only 2 are PG&E leaks
    - 1 on relief valve
    - 1 on Valve body bleed within Redacted
    - No Girth Weld leaks found
  
- Provided answer to concern over section of API 1104 regarding source material being more than 13mm from pipe
  - Explained that WIX Reader sheet provided dimensions from source, to point through center of pipe, and to inner wall of opposite side.
  - Terence was satisfied with David Culbertson's explanation and graphic of the situation
  
- Reviewed status of LLNL Contract. Terence stated he was comfortable with where we were at. Looking to finalize by 12/31/13
- Reviewed WV-5 Completion letter from Redacted
  - Identified no Reader Sheets from WIX included
  - Brian Daubin to provide WIX Reader Sheets for WV-5
