Re: Notice of Evidence Collection by Cal OSHA and ATF at the Kern Power Plant site on December 5, 2013 beginning at 10:00 a.m.

PLEASE BE ADVISED THAT the Pacific Gas and Electric Company ("PG&E") has been advised that Cal OSHA and the Bureau of Alcohol, Tobacco, Firearms and Explosives ("ATF") intend to collect the physical blast shrapnel and debris evidence that exists outside the collapsed structures on the grounds of PG&E's Kern Power Plant site at 2401 Coffee Road, Bakersfield, CA on **Thursday, December 5, 2013 starting at 10:00 a.m.** PG&E is advised that the approximate location and the rough weights and dimensions of pieces of evidence will be recorded in the field, the evidence will be marked and placed in separate containers, and will be held by CalOSHA in a secure evidence storage facility in Bakersfield for later inspection and analysis. PG&E is advised that CalOSHA and ATF do not intend to remove evidence from the rubble of the collapsed structures on the site at this time.

Access to the PG&E facility is limited and may be denied at the discretion of PG&E. No person will be allowed access to the Kern Power Plant site without appropriate personal protection equipment, including ALL of the following: Approved helmet or "hard-hat", Approved safety glasses; Day-glo and reflective safety jacket or vest; closed heel and toe leather shoes or boots; long pants and long sleeved shirt. PG&E is not responsible for providing personal protection equipment.
