Subject: R11 02 019, Courtesy Notification Regarding an Over-Pressure Event on the Suction Piping at Topock Compressor Station

In consultation with ALJ Bushey, PG&E is providing the attached "Courtesy Notification Regarding an Over-Pressure Event on the Suction Piping at Topock Compressor Station," which PG&E transmitted to SED on January 21, 2014. As explained in the notification, this 11-minute pressure excursion that occurred on January 10, 2014 exceeded the Maximum Allowable Operating Pressure (MAOP) by 6%, which is below the PHMSA and CPUC reporting threshold; PG&E is providing this courtesy notification because these station facilities were subject to Decision 11-10-010 in this proceeding. A copy of that decision is also attached for reference. As noted in the decision, PG&E tested the subject piping to pressures greater than 1.5 times the current MAOP.
