Subject: R1206013 - Phase 2 Schedule

The procedural schedule for R1206013 Phase 2 will be as follows. Note that I have allocated 3 days for evidentiary hearings – 1 day for each utility. As we move closer to the hearing dates we will determine if that allocation is appropriate.

Also, this email confirms the directions to the utilities made at the January 8, 2014 prehearing conference regarding additional supplemental testimony.

(1) Utilities should serve simplified rate change proposals for 2014. These proposals should retain the current rate design structure and avoid rate shock. If the rate change proposals are not simplified, it is not realistic to expect a decision on the proposals in time for summer 2014.

(2) Utilities should work with Energy Division to develop testimony that includes useful comparisons between proposed and existing rates in a standardized format.

Utilities and interested parties may contact Energy Division to provide input on what additional testimony is most useful to parties. The utilities are also encouraged to work directly with the other parties.

In addition, in light of the many comments by parties at the PHC, it is necessary for the utilities to inventory residential rate design issues to be resolved in this and other proceedings. The inventory will be used to clarify what aspects of residential rate design will be addressed in this proceeding and to ensure that all issues are being addressed in an appropriate Commission proceeding.

A formal Amended Scoping Memo memorializing the schedule will follow soon.
