As you all may know, I have been trying to improve the public access to advice letter fillings and the related documents so that practitioners and the general public can easily find ALs, protests, comments, suspensions, dispositions, etc. For now there is not an easy solution within the CPUC since our IT resources are limited and prioritized elsewhere right now. Instead, I would like to work with the utilities to find a way to do more of this on your websites with some clear links from the CPUC site to your sites. Right now you all post the actual ALs and disposition letters but not the protests or replies. Also the sites are not all that searchable and you really need to know what you are looking for (in some cases you will even need to know the AL number) to find what you need.

I have assigned Nicholas Castillo to coordinate this for Energy Divisions and I would like to ask each of you to find someone from your company that can work with Nick on this project.

This is a priority of mine and I would like to have new the new functions up and running by June 30<sup>th</sup> of this year.
