Pursuant to PUC Code §454, the Commission's Rules of Practice and Procedure Rule 2.1-2.3 and 3.2, the Assigned Commissioner's Ruling ("ACR") issued in Rulemaking 12-06-013 on October 25, 2013, and Assembly Bill 327 ("AB 327"), San Diego Gas & Electric Company (U 902-E) ("SDG&E") submits this *Supplemental Filing for Phase 2 Interim Rate Changes*. This Supplemental Filing is designed to comply with the guidance provided in the ACR, the November 14, 2013 e-mail ruling of Administrative Law Judge ("ALJ") Jeanne M. McKinney, as well as AB 327. This Supplemental Filing and supporting testimony is available to all interested parties and to the public. Any recipient of this Notice of Availability may request a copy of the filing. This Supplemental Filing presents SDG&E's Interim Rate Change proposals. SDG&E proposes the following:

- Increases to lower tier rates (increase Tier 1 rate to Tier 2 levels) to provide relief to upper tier rates;
- To consolidate Tiers 3 & 4 in this proceeding, in the event SDG&E does not receive approval for the consolidation of Tiers 3 & 4 in its pending Test Year 2012 General Rate Case Phase 2 Application 11-10-002, originally filed October 3, 2011;
- To move California Alternate Rates for Energy ("CARE") subsidies from rates to a line item on the bill for residential and non-residential CARE customers;
- A transition path to bring the effective CARE discount within 30-35% for residential and non-residential CARE customers; and
- A four year transition for rates applicable to non-CARE medical baseline customers resulting from SDG&E's proposals related to CARE and non-CARE tiered rates.

The proposals SDG&E is making herein have been carefully designed to comply with the requirements of AB 327 as well as all of the guidance provided in the ACR including the expectation that, "Rate design changes proposed for 2014 should be modest, easy to evaluate, and consistent with AB 327."



NOTIFICATION OF FILING FOR INTERIM RESIDENTIAL RATE CHANGES AND POTENTIAL IMPACT ON ELECTRIC RATES PHASE 2 OF RULEMAKING 12-06-013

On November 22, 2013, San Diego Gas & Electric Company (SDG&E) filed a request to implement interim rate changes with the California Public Utilities Commission (CPUC) pursuant to Assembly Bill (AB) 327 and the Assigned Commissioner Ruling of Commissioner Michael R. Peevey, dated October 25, 2013. SDG&E's filing is part of the CPUC's efforts to explore improved residential rate design structures, currently being examined in the context of the CPUC's Order Instituting Rulemaking (R.) 12-06-013.

The changes proposed in SDG&E's filing are limited to:

1. Changes in residential tiered rates - SDG&E proposes to move from a four-tier rate design to a two-tiered rate design.
2. Changes to the California Alternate Rates for Energy (CARE) discounts for income-qualified households - SDG&E proposes to implement the CARE discount through a line item on customer bills, and a transition path to reach the legislated 30-35% average effective discount.

Tiered Rate Proposal

Currently, residential customers pay tiered rates for electric service based on something called their baseline usage. Baseline is a state law which currently provides residential customers a certain amount of energy at the lowest rate. In general, the amount of energy is about 60 to 60 percent of the system-wide average residential customer. SDG&E's current standard residential rates have a four-tiered rate structure as follows:

- Tier 1: usage up to Baseline;
- Tier 2: 101%-130% of Baseline;
- Tier 3: 131%-200% of Baseline; and
- Tier 4: Above 200% of Baseline.

Lower tier rates are now well below cost and upper tier rates are now well above cost as a result of legislation that was adopted following the California energy crisis in 2001. 

On November 22, 2013, San Diego Gas & Electric Company (SDG&E®) filed a request to implement interim rate changes with the California Public Utilities Commission (CPUC) pursuant to Assembly Bill (AB) 327 and the Assigned Commissioner Ruling of Commissioner Michael R. Peevey, dated October 25, 2013. SDG&E's filing is part of the CPUC's efforts to explore improved residential rate design structures, currently being examined in the context of the CPUC's Order Instituting Rulemaking (R.) 12-06-013.

The changes proposed in SDG&E's filing are limited to:

1. Changes in residential tiered rates - SDG&E proposes to move from a four-tier rate design to a two-tiered rate design.
2. Changes to the California Alternate Rates for Energy (CARE) discounts for income-qualified households – SDG&E proposes to implement the CARE discount through a line item on customer bills, and a transition path to reach the legislated 30-35% average effective discount.

TIERED RATE PROPOSAL

Currently, residential customers pay tiered rates for electric service based on something called their baseline usage. Baseline is a state law which currently provides residential customers a certain amount of energy at the lowest rate. In general, the amount of energy is about 50 to 60 percent of the system-wide average residential customer. SDG&E's current standard residential rates have a four-tiered rate structure as follows:

- Tier 1: usage up to Baseline;
- Tier 2: 101%-130% of Baseline;
- Tier 3: 131%-200% of Baseline; and
- Tier 4: Above 200% of Baseline.

Lower tier rates are now well below cost and upper tier rates are now well above cost as a result of legislation that was adopted following the California energy crisis in 2001. AB 327 lifted these legislative



limitations and authorized the CPUC to correct many of the flaws that exist under this rate design. Therefore, SDG&E proposes in this filing to move to a two-tiered rate structure with up to 130% of baseline usage being billed at the current Tier 2 rate of \$0.17 per kWh and above 131% of baseline usage being billed at \$0.29 per kWh.¹

The table below illustrates SDG&E's proposal regarding revisions to the tiered structure:

CARE PROPOSAL

The CARE program provides a monthly discount on energy bills for income-qualified households. Today, because CARE customers receive a 20% line item discount on their bill plus are exempt from paying certain rate components, the current effective CARE discount is approximately 39% for residential CARE, 48% for small commercial CARE, and 49% for Medium and Large Commercial and Industrial (C&I) CARE. AB 327 allows for the discount to be removed from the rates to a line item discount to create greater price transparency and to efficiently manage the CARE discount percentage going forward.

¹ Consolidation Tiers 3 and 4 was requested in SDG&E's General Rate Case Phase 2 Application (A.) 11-10-002. At the time of this filing, A.11-10-002 is still pending before the CPUC. Should a timely decision not be reached in that proceeding, SDG&E will seek consolidation of Tiers 3 and 4 in this proceeding.

AB 327 also sets the CARE discount to be between 30% and 35%. SDG&E proposes a transition path to reach the 30-35% effective discount range with annual reductions by 2.5% a year.

In addition, SDG&E's proposed changes to non-CARE and CARE rates will have impacts to medical baseline rates. SDG&E proposes a 4-year transition for medical baseline rates from their current Tier 1 rates to the proposed Tier 1 rates to mitigate the impacts to these customers.

ILLUSTRATIVE IMPACT ON ELECTRIC RATES AND BILLS

If the CPUC approves SDG&E's request, a typical non-CARE residential customer living in the inland climate zone and using 500 kilowatt-hours per month could see a monthly summer bill increase of 4.9%, or \$4.33, from a current monthly bill of \$88.92 to \$93.25.

As seen in the table below, a typical CARE residential customer living in the inland climate zone and using 500 kilowatt-hours per month could see a monthly summer bill increase of 1.1%, or \$0.61, from a current monthly bill of \$56.46 to \$57.07.

CPUC PROCESS

This filing will be assigned to an Administrative Law Judge (ALJ) who will determine how to receive evidence and other related documents, necessary for the CPUC to establish a record upon which to base its decision. Evidentiary Hearings (EHs) may be held where parties of record will present their testimony and may be subject to cross-examination by other parties. These EHs are open to the public, but only those who are parties of record can participate. After considering all proposals and all evidence presented during the formal hearing process, the assigned ALJ will issue a proposed decision determining whether to adopt all or part of SDG&E's request, modify it, or deny it. The CPUC Commissioners may sponsor an alternate decision and the issue will be decided at a scheduled Commission Voting Meeting.


