After hour access card holders must swipe their card on the entrance side before they swipe to exit, unless they drove into the garage after 3 p.m. Thank you for your patience and understanding. 2) Beginning March 1, 2014, the automobile parking rate for Monthly Parkers will increase by \$10 (from \$55 to \$65). This increase is in accordance with the Commuter Check Program - FAQ located on the CPUC Intranet under the Automobile section.
