**On Wednesday, January 29, 2014, Pacific Gas and Electric Company filed

Modifications to the Tariff and Standard Contract for the Purchase of Eligible Renewable Generation from the Renewable Market Adjusting Program

Specifically, PG&E is requesting to incorporate the approved 2013 time of delivery (“TOD”) factors, incorporate the updated standard term and condition (“STC”) 2 for the Green Attributes provision, and make one minor administrative revision to Appendix K (Form of General Consent to Assignment) of the Renewable Market Adjusting Tariff (“ReMAT”) standard form contract.
