Subject: Note on AA-EE assumptions proposed for Planning Assumptions and Scenarios

Dear Parties to Proceedings R. 12-03-014 and R. 11-10-023,

On December 18th, 2013, CPUC Energy Division staff, in collaboration with the CAISO and CEC, hosted a workshop to solicit feedback on planning assumptions, scenarios, and renewable resource portfolios to be used in the CPUC 2014-2015 Long Term Procurement Plan proceeding and provided to the CAISO for use in its 2014-2015 Transmission Planning Process.

The CPUC staff's workshop documents noted that the final AA-EE scenarios proposed for use in CPUC, CAISO, and CEC resource planning studies were "to be determined" and expected to be documented at the CEC's Jan 15, 2014 Business meeting. The final proposal of AA-EE to be used for planning studies has now been made as Mid-Low for local reliability studies and Mid-Mid for all other cases. The documentation of this decision is described on pp. 92-94 of this CEC document:
