Re: 2013 Annual Reports By Pacific Gas and Electric Company

Dear Mr. Clanon:

Pacific Gas and Electric Company (PG&E) respectfully requests the extension of due dates of certain annual reports for the year 2013. Specifically, PG&E requests extensions from March 31, 2014 to June 2, 2014, for certain of the General Order (G.O.) 77-M report items for 2014. PG&E also requests extensions of the due dates for the G.O. 104-A, and Gas Pipeline Replacement Program (GPRP) annual reports from March 31, 2014 to April 30, 2014. These requested extensions are consistent with those previously granted. Consistent with its extension request for the GPRP Annual Progress Report, PG&E is also requesting an extension of the due date for the Gas Meter Protection Program (MPP) annual report, which is to be filed at the same time as the GPRP report.

PG&E is required to file the following annual reports for the previous calendar year by March 31 annually:

1. Per G.O. 77-M, Annual Report of Data on Dues, Donations, Subscriptions, Contributions and Legal Fees;
2. Per G.O. 104-A, PG&E Annual Report;
3. Per G.O. 104-A, Standard Pacific Gas Line, Inc. Annual Report;
4. Per Decision 86-12-095, GPRP Annual Progress Report; and
5. Per Decision 89-12-057, MPP Annual Report (to be filed at the same time as the GPRP Annual Progress Report).

For the G.O. 77-M report, per Decision 06-12-029, compensation items are due to be filed on or before May 31 of each year. (This year May 31 falls on a Saturday so that the compensation items would be due on June 2.) However, G.O. 77-M still requires items relating to dues, donations, subscriptions, contributions and payments to attorneys be filed by March 31 each year. In order to allow sufficient time to organize the recorded information from the prior calendar year, and to enable PG&E to file a single rather than bifurcated G.O. 77-M report,


PG&E requests an extension of the due date for these items to June 2, consistent with the due date for compensation data.

For the G.O. 104-A reports, part of the financial information required in these reports is, with minor exceptions, duplicative of the information required in annual reports submitted to the Federal Energy Regulatory Commission (FERC) that are due on or before April 18 each year. In past years, PG&E requested extensions until April 30 of the CPUC annual report due dates to ensure consistency with the annual reports to the FERC. PG&E is requesting an extension from March 31 to April 30, 2014, in the due dates for the G.O. 104-A reports for 2013.

For the GPRP and MPP, PG&E is requesting an extension from March 31 to April 30, 2014 for these reports to have more time to review and analyze the data.
