The utilities are requested to use these attached templates to show comparisons between proposed and existing rates in a standardized format which includes comparisons of proposed rates to rates in affect in November, 2014, as well as rates in effect in early 2014. The templates were developed with input from some of the parties as well as the IOUs.
