Hello,

Attached is a staff straw proposal to create a process for integrating risk assessment into the utility's General Rate Case funding requests, and creating a simple verification process that will show what was authorized versus what was spent. This is one proposal and we're certainly open to refinement or even a new proposal. The assigned ALJ – John Wong – will issue a Ruling next week giving further details. Workshops will be held on March 19th, 20th, & 21st beginning at 9:30am in the CPUC auditorium (the first two days is to discuss the proposal while the third day is to discuss how to streamline the GRC process itself). The Prehearing Conference (PHC) will be held on April 29th at 10am.

We are treating this proposal as a first draft. Workshops will follow and allow us to brainstorm with all stakeholders then we will revise/refine the proposal based on the workshops. Finally, we will re-issue the proposal after the workshops taking into consideration comments from stakeholders and at that point we will ask for formal opening and reply comments.

The attached staff straw proposal was reviewed and commented on by Underwriters Laboratories (UL). UL will also participate in our upcoming workshops.
