At this workshop, which is free and open to the public, Linda Connell, NASA's Aviation Safety Reporting System Director, will explain what these systems are and NASA's experience operating safety reporting systems for the aviation and rail industries. The objective of this workshop is to promote awareness and potential increased application of safety reporting systems within California.
