I got your inquiry about PG&E's 851 AL that you sent to Ed Randolph. It would be helpful to understand the timing of Samsung. It would also be helpful if PG&E please (pretty please) notify us upon filing if your 851 or NOC ALs are urgent – rather than us hearing from the customer or generator. While I wish we did everything instantly, we are often juggling priorities --- and we seem to always hear from PG&E or a developer after you already need something urgently.

Having said that, this 851 seems straightforward and unprotested, so it shouldn't be hard to process. I'm the branch manager – so if you have follow up questions, give me a call or send me an email.
