Stephanie,

We apologize for not providing the Commission with an update. Once the contract terms and text were finalized by PG&E and CCSE per [Redacted] email, it was routed for internal signature which has taken a few days. The contract has been issued today for CCSE's signature.

As you are well aware, this is a new direct award contract to CCSE in the amount of approximately \$40 million, in compliance with the Decision. PG&E has contracting policies where contracts greater than \$20 million require the review and approval by our Law, Tax, Accounting, Economic and Project Analysis, and Credit Risk Teams. This review is designed to make sure that the appropriate functions within PG&E know about the contract and can prepare to perform their responsibilities in connection with it. As soon as this review was completed, the contract was routed for signature.

We understand the importance of getting this contract executed and have been working diligently on it, and moving the final contract through our internal approval process as expeditiously as possible. If you have any other questions, please let us know.

Dear Shirley, it has come to the CPUC's attention that there is still not a contract between CCSE and PG&E to implement statewide marketing for 2014-2015. As a reminder, PG&E is out of compliance with D. 13-12-038, ordering paragraph 17. PG&E and CCSE received an extension through January 31, 2014 from the Executive Director to comply with this ordering paragraph. A request for additional extension of time to complete a contract was rejected by the Executive Director on January 30, 2014.

On February 3, 2014, Redacted of PG&E sent an email to CPUC staff and supervisors explaining that the contract was complete and would be routed for signatures.

PG&E has taken an additional 9 business days, and has still failed to produce a contract for signature. PG&E should make it a highest priority to complete this contract by COB today.

Ordering Paragraph from Decision 13-12-038

17. For the 2014-2015 statewide marketing, education, and outreach campaign, Pacific Gas and Electric Company, on behalf of itself, Southern California Edison Company, San Diego Gas & Electric Company, and Southern California Gas Company, shall contract with the California Center for Sustainable Energy (CCSE) no later than January 1, 2014, to begin activities to allow CCSE to fully implement the program established in this decision beginning in 2014.
