Dear Mr. Harris,

Pursuant to the California Public Records Act, Government Code § 6250 *et seq.*, please consider this communication a request from *The Wall Street Journal* for documents pertaining to the April 16, 2013 sabotage attack on the Metcalf electrical substation owned by PG&E Corp, located in San Jose, Calif.

The Wall Street Journal is requesting copies of any and all documents, records, emails, photographs or other materials – including communications oral or written – related to damage caused at that substation, an investigation into that attack, and information on subsequent repairs, including steps taken to bolster defenses against any future attacks.

I am attaching a CPUC incident report that makes reference to communications, after the attack, between the utility and commission staff. I am requesting copies of those emails and any related materials, as well.

Pursuant to Cal. Gov't Code § 6253(c), we expect a response within 10 days and would very much appreciate a speedier response, if possible. If this request is denied in whole or in part, we will expect a detailed justification for the withholding of records. We also request any segregable portions of records that are otherwise not disclosed by the California Public Utilities Commission in response to this request. *The Wall Street Journal* reserves the right to appeal any denial of this request.

As we are requesting this information for publication, we request a waiver of fees.

I would be happy to work with you to find a way to fulfill this request with the least labor on your end. Please do not hesitate to call me, at the numbers shown below, if I can clarify this request.
