The attached letter dated February 6, 2014 from the Commission's Executive Director, Mr. Paul Clanon, grants a request from the California Farm Bureau (CFBF), the Agricultural Energy Consumers Association (AECA), the South San Joaquin Irrigation District (SSJID), and Pacific Gas and Electric Company (PG&E) for a one-year extension of the termination date for agricultural schedules AG-R and AG-V. Under the settlement approved in D.11-12-053, schedules AG-R and AG-V were set to terminate starting March 1, 2014. With approval of the CFBF, AECA, SSJID and PG&E request, the termination date is deferred to March 1, 2015.

The instructions in the Executive Director's letter directed service on parties in PG&E's currently pending GRC case, but referenced the docket number for another case.
