Commissioner,

Amy and I talked again this afternoon. PG&E regulatory is apparently playing ignorant about this presentation, saying they knew nothing of it. That's odd since we were told at the briefing that the presentation had been made many times before, in other states and other countries. PG&E also claimed it was being as transparent as possible. Nothing was designated as proprietary or confidential in PG&E's presentation. The presentation occurred in a public place where students walking by could easily see (and hear) the presentations.

Amy and I are of the view that we should ask PG&E to give the same presentation here to CPUC staff. The event should be hosted by SED, Energy, and Communications Divisions. We should also invite AT&T and Level 3, whose cables were cut as part of the Metcalf incident, to make presentations in response to PG&E's.

Amy and I agreed that it's bizarre that the CPUC's divisions are not talk to each other about the security issues implicated in the interdependence of the communications and electric grids.
