Subject: R1206013 Email Ruling Shortening Time for Settlement Comments

On March 4, 2014, a settlement proposal was filed for the Southern California Edison Company (SCE) Phase 2 Rate Change Proposal. (Joint Motion of SCE, The Office of Ratepayer Advocates (ORA), The Utility Reform Network (TURN), The Coalition of California Utility Employees, The Sierra Club and The Natural Resources Defense Council for Adoption of Settlement Agreement for Phase 2 Simplified Summer 2014 Residential Rate Design Changes.)

On March 5, 2014, a settlement proposal was filed for the Pacific Gas & Electric Company (PG&E) Phase 2 Rate Change Proposal. (Joint Motion of PG&E, ORA and TURN to Adopt Settlement.)

Because the rate changes sought are time-sensitive, the SCE Joint Motion included a request to shorten the time for commenting on the settlement. The SCE Joint Motion also requests that a portion of the Evidentiary Hearings scheduled for March 24 – 26, 2014 be set aside to for a hearing (with a panel of sponsoring witnesses) to accommodate questions from the assigned ALJ regarding the proposed settlement.

In light of the above, and in order to promote consistent, fair and efficient review of the two settlement proposals, SCE's schedule requests are granted, and the same treatment will be applied to the PG&E Proposed Settlement.

This Email Ruling does the following:

(1) Notifies all parties that a portion of the Evidentiary Hearings scheduled for March 24 – 26, 2014 will be set aside for hearings on the SCE Proposed Settlement and the PG&E Proposed Settlement. A more detailed schedule for the Evidentiary Hearings will be determined later this month.

(2) The time period for commenting on the SCE Joint Motion and the PG&E Joint Motion are reduced as follows:
