Dear Parties to Proceedings R. 13-12-010 and R. 11-10-023,

On February 27th 2014, the CPUC published an Assigned Commissioner's Ruling (ACR) on planning assumptions, scenarios, and RPS portfolios as part of the CPUC's 2014-2015 Long Term Procurement Plan (LTPP) proceeding. This ACR is also intended for use in the CAISO's 2014-2015 Transmission Planning Process.

Please note that the "Amended Attachment to 2-27-14 ACR" (3/18/2014) includes three corrections to the original ACR as follows:

1. Corrections to Table 3 in section 4.2.5. The original table tallied DR ex ante impacts using 1-in-2 weather year data, however, the intent was to tally 1-in-10 weather year data. The corrected table clarifies this and now lists the DR Program MW in 2024 using 1-in-10 weather year ex ante impacts.
2. Updates to Table 4 in section 4.2.6. The original table summarized the seven RPS portfolios with limited information on how the portfolios were built and the intended use. The updated table provides greater detail on the information used to calculate the renewable net short for each portfolio and the intended use of the portfolio.
3. Corrections to Table 7 in the Appendix. The original table contained formatting that inadvertently hid several cells in the table. The corrected table now shows all cells.

Due to formatting differences, the page numbering in the Amended Attachment has changed from the page numbering in the original ACR.

The final RPS Calculator files will be announced by separate email when they become available.
