SDG&E has solicited cross-examination estimates from all parties regarding the investor-owned utilities' Phase 2 Interim Rate Change proposals in R.12-06-013. UCAN, ORA, TURN, Greenlining Institute, CforAT, CFC, SDCAN, PG&E, and SCE have all provided responses indicating that at this time no cross-examination time is being requested. SDCAN has indicated that if any cross-examination time is needed outside of questions that may be presented to the settlement panels, it will be limited. SDG&E will also not be seeking to cross-examine any individual witnesses in this proceeding.

SDG&E is informed that TURN has requested that the first day of evidentiary hearings in this proceeding, March 24, be canceled with hearings to commence on March 25 and 26, at which time the utilities and their respective settlement panels would present their settlement agreements and make themselves available for cross-examination. On the basis of the extremely limited cross-examination time that has been requested herein, SDG&E supports TURN's request.
