I just spoke with counsel for SCE and SDG&E about the order of witness panels supporting the

We propose the following order:

Marcus (TURN).

As far as we know, all panelists are available starting Tuesday.

If the panels were each to take no more than 90 minutes, we believe the hearing should be able  
to be competed in one day.

We were assuming at 9:30am start time, based on the CPUC's Daily Calendar.

However, some witnesses need to travel long distances that morning, so might prefer to start instead at 10am, if possible.

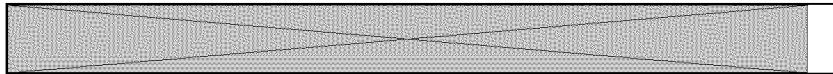
