Subject: R1206013 Email Ruling Changing Evidentiary Hearing Schedule; Granting Motion for Party Status; and Setting Forth Procedure for Evidence at the Hearings

This Email Ruling makes adjustments to the schedule for Evidentiary Hearings and sets forth certain specific procedures to be followed for evidence.

This Email Ruling also grants the November 21, 2013 Motion of California Solar Energy Industries Association for party status.

- (1) SDG&E will serve a status update on today's settlement conference by 6 pm today (Monday, March 24, 2014).
- (2) Tuesday's scheduled Evidentiary Hearings will be devoted to witness panels sponsoring settlement proposals (Settlement Panels).
- (3) Tuesday's hearings will start at 10 a.m.

- (4) The order of the Settlement Panels proposed by PG&E is adopted, with each panel expected to take approximately 90 minutes.
 - a. PG&E: Dennis Keane and Phil Quadrini (PG&E); Lee-Whei Tan (ORA), and Bill Marcus (TURN).
 - b. SCE: Russ Garwacki (SCE), Lee-Whei Tan (ORA), and Bill Marcus (TURN).
 - c. SDG&E: Chuck Manzuk and Cindee Fang (SDG&E), Lee-Whei Tan (ORA), and Bill Marcus (TURN).
- (5) Each party must bring 5 copies of any written testimony to be offered.
 - a. Exhibit Numbering: Each party should number their exhibits with party-specific abbreviation followed by document number begin with 01 (for example, Exhibit Number SCE-01).
 - b. For efficiency, bring a list of exhibits expected to be offered including Exhibit number, document title, and sponsoring witness.

Instructions for Settlement Panels:

Each Settlement Panel presentation should include an overview of the proposed settlement that includes the following elements:

- (1) Main points of the settlement proposal and reasons why the settlement proposal is in the public interest.
- (2) Explanation of bill impact models, including being prepared to answer questions regarding assumptions and data sources.
- (3) Example of how the proposed allocation formula would be used to calculate the rate once actual revenue requirement is approved.
- (4) Summarize how the rates proposed in the settlement would meet statutory requirements and the optimal rate design principles developed in this proceeding. In particular, parties should be prepared to describe analysis and supporting documentation regarding the impact of the proposed changes on affordability.
- (5) Explain the impact of the proposal on FERA and medical baseline customers.

In light of the fact no parties have requested cross-examination time, and no parties protested

the proposed PG&E and SCE settlements, we expect that the hearings on the PG&E and SCE settlement proposals will be completed via the Tuesday Settlement Panels. This leaves Wednesday available for evidentiary hearings on the SDG&E proposal if SDG&E does not have a sponsored settlement proposal for presentation on Tuesday. We therefore are leaving Wednesday March 28, 2014 on the schedule. If hearings on SDG&E are not completed by Wednesday, we have reserved Thursday afternoon for additional hearings.
