1/ The Annual Load Impact Report filings and service of the draft Load Impact Reports were originally ordered in D.08-04-050 and served in R.07-01-041. Pursuant to Administrative Law Judge Hymes March 13, 2014 ruling, the April 2014 Load Impact Reports, and future reports, are to be served and filed in the new Demand Response OIR, R.13-09-011.

The titles of the draft local load impact reports are:
