SAN FRANCISCO, March 3, 2014 - The California Public Utilities Commission (CPUC) today announced that its General Counsel, Frank Lindh, is resigning to accept a new position as a partner in the San Francisco office of Crowell & Moring LLP, a national law firm. Mr. Lindh has served as the CPUC's General Counsel since June 2008. The CPUC will conduct a national search to select a new General Counsel.

"We wish Frank all the best in his new position," said CPUC President Michael R. Peevey. "He has been a wonderful General Counsel and public servant. His vision, hard work, and strong commitment to legal ethics will be sorely missed at the CPUC."

Assistant Chief Administrative Law Judge Timothy J. Sullivan will serve as Acting Chief Administrative Law Judge.
