Subject: R1206013 Email Ruling Changing Evidentiary Hearing Schedule and Granting Motion for Shortened Notice of Settlement Conference

Evidentiary Hearings have been scheduled in Phase 2 of this proceeding for March 24 – March 26, 2014.

By email on March 17, 2014, we asked that parties meet and confer and provide estimates for witness cross-examination by no later than March 20, 2014. As of March 21, 2014, no party has indicated the need for cross-examination. Several parties have requested cancelling the first day of Evidentiary Hearings.

On Thursday, March 20, 2014, San Diego Gas & Electric Company (SDG&E) filed a **MOTION FOR SHORTENED NOTICE PERIOD TO SERVE NOTICE OF SETTLEMENT CONFERENCE ON PHASE 2 INTERIM RATE CHANGES and SAN DIEGO GAS & ELECTRIC COMPANY (U902E) NOTICE OF SETTLEMENT CONFERENCE ON PHASE 2 INTERIM RATE CHANGES. The Settlement Conference is scheduled for March 24, 2014. SDG&E puts forth several grounds**

for allowing a March 24, 2014 settlement conference. First, SDG&E states that there is an agreement in principle between SDG&E and several other parties. Second, to date no parties have indicated the need for cross-examination at the scheduled hearings.

Based on the foregoing, and pursuant to the authority in Rule 1.2 and Rule 9.1 of the Commission's Rules of Practice and Procedure, we are granting SDG&E's motion to shorten the time period for noticing the March 24, 2014 Settlement Conference. We are also cancelling the first day of Evidentiary Hearings.

IT IS RULED THAT:

- (1) The Evidentiary Hearing schedule for Monday March 24, 2014 is cancelled. The Evidentiary Hearings scheduled for March 25 and March 26 remain on the schedule.
- (2) SDG&E's Motion to shorten the notice period for settlement conference is granted.
