As Tony and Chris noted, our strong belief is that allegations that PG&E intentionally violated the federal Pipeline Safety Act are not supported by the evidence. We believe our employees have always acted in good faith to provide our customers with safe, reliable, affordable and clean energy.

As this case plays out, perhaps over the next year or two, I encourage you to never lose sight of the important work we still have left to do and to always put safety first.
