TO ALL PARTIES:

In support of the Phase 2 settlement in this proceeding among PG&E, ORA and TURN, PG&E is serving the attached exhibit which we will ask to be admitted into the record. Consistent with the proposed settlement, this exhibit provides the illustrative rates for PG&E's voluntary time-of use (TOU) and seasonal rate schedules, showing how the difference between the top-tiered and bottom-tiered rates would be similarly narrowed under the settlement for three illustrative levels of revenue requirement increase: no change to revenue requirements, approval of 50 percent of all proposed revenue requirement increases, and approval of 100 percent of all proposed revenue requirements. The rules for setting rates for PG&E's voluntary TOU and seasonal rates described in the exhibit are consistent with the description on pp. 2-28 – 2-29 of PG&E's January 28, 2014 prepared testimony.
