CPUC Decision (D.)09-08-027 directs the DRMEC to conduct an annual public workshop presenting the results of demand response load impact evaluations conducted under the DRMEC's oversight. As part of the annual Load Impact workshop, Ordering Paragraph 12 of D.12-04-045 also directs the Utilities to address the baseline comparison analysis.
