Subject: Notice of Expected Corrections to 2014 LTPP Proceeding ACR on Planning Assumptions and Scenarios

Dear Parties to Proceedings R. 13-12-010 and R. 11-10-023,

This email serves as advance notice that CPUC Energy Division, in consultation with the California Energy Commission (CEC), has determined technical updates are required to the February 27, 2014 Assigned Commissioner's Ruling (ACR) on Planning Assumptions and Scenarios for use in the 2014 LTPP and 2014-15 CAISO TPP. The corrections include clarifying language, avoided transmission and distribution loss accounting for demand-side resources, and minor revisions to the Additional Achievable Energy Efficiency (AAEE) projections in the CEC's IEPR demand forecast. The ALJ expects to issue a Ruling soon to describe these technical updates in detail.
