Pursuant to Rule 1.9 of the Commission's Rules of Practice and Procedure, Pacific Gas and Electric Company (PG&E) provides notice to the service list in R.13-09-011, the members of the Demand Response Measurement Evaluation Committee (DRMEC), the Joint Staff, and the California Independent System Operator (CAISO) that the following load impact reports for program year 2013, with their appendices, are available on PG&E's website:

These documents were prepared in compliance with the load impact protocol requirements adopted in D.08-04-050, as modified by D.10-04-006, and D.10-06-034, for the summary of the 2014-2024 Demand Response program evaluations, and the SmartRate™ ex-post load impact evaluation requirement in D.06-07-027.

PG&E makes its load impact reports available pursuant to D.08-04-050. Service on parties now occurs in R.13-09-011 pursuant to the directions in the March 13, 2014 ruling issued by Administrative Law Judge Hymes by e-mail. The report on SmartRate™ is included in the 2013 Load Impact Evaluation of Pacific Gas and Electric Company's Residential Time-Based

Pricing Programs, and is made available pursuant to D.06-07-027 and D.09-10-037. PG&E is also providing the baseline analysis for the Aggregator Managed Portfolio (AMP), the Capacity Bidding Program (CBP) and the Demand Bidding Program (DBP), as required by Ordering Paragraph 11 of D.12-04-045, for April 1, 2014.^{1/}
