Hello Parties to R.13-11-006,

Thank you again for taking time away from your busy schedules to join us for three days of workshops. I'm super excited that we're on to something. I think today's panel 6 was very fruitful as was panel 3. They were all very insightful, but in my view those two panel discussions clarified a lot and gave us a clear roadmap.

As promised, attached is the word version of the straw proposal. Here are to do's for you:

1. By **April 7th**, please redline the proposal or come up with a new one that you think best gets us to our goal of to developing fundamental regulatory processes for defining, acquiring, and disseminating risk-based information that supports rate-setting and project prioritizing decisions.
 - a. Remember that I don't want comments. I want revisions to the word document. Revisions that are realistic and implementable.
 - b. A section that is missing from the straw proposal is how to streamline the GRC process. This is a separate section which you can create. Again, no thoughts or comments to us just actual steps that make the process more streamlined – i.e. **realistic and implementable steps**.
 - c. Parties can either send me separate redline revisions or get together amongst yourselves and send me a combined proposal or several combined proposals.

2. In about two weeks after April 7th we will re-issue the straw proposal based on the redline revisions that we get. The ALJ will attach the straw proposal as part of an ALJ Ruling and that's when it'll become part of the record. You will each then have an opportunity to file opening and reply comments on the record to respond to the re-issued/revised straw proposal.

Revisions = realistic and implementable solutions with details, and must uphold the idea of a process that is transparent, consistent to the extent possible, and must take into account stakeholder feedback!

Thank you again for your assistance, your expertise, and your patience. Please don't reply all to this email. If you have any questions, please don't hesitate to email me or ask for a meeting.
