I wanted to update you on the status of our activities in the East Bay cities relative to tree management in gas rights of way.

We are not removing any trees in city franchised rights of way where our gas transmission lines are located.

We are continuing two communication paths: (1) with city representatives and (2) with individual residential customers whose property was previously identified as having trees needing removal.

We attended a City Council meeting in Danville this week, and have scheduled a meeting with the City of Concord. We also have provided Walnut Creek with additional tree-related information.

| We are considering holding a technical workshop in the East Bay to facilitate a public discussion among city officials such as public works directors, city managers, and arborists along with PG&E pipeline engineers and consultants.
