Hi Anu,

Thank you again for coming in with Kevin, Stephanie, and Meredith.

I spoke further with Raymond and relayed his analysis to President Peevey.

President Peevey's request still stands:

1. Provide the underlying source file for the solar PV siting map in downloadable form on the utility's site.

2. Remove the obfuscation of substation and feeder line locations and names, so that actual locations and names are presented in the downloadable source file (GIS shapefile, Google Earth KMZ file, etc.) and presented in the mapping interface.

a. Note: The Commission does not see a legal justification for the existing obfuscation, as critical infrastructure concerns were already disposed of in the RAM Decision and it was determined that the claim that such data should be kept confidential was not valid (see D.10-12-048 at p.72-73 and FOF #46 at p.86).

3. Remove any constraints in any user licensing agreement with regard to prohibiting use of the downloaded data from the site for specific uses and requiring express written consent of the utility.

We hope PG&E can accomplish this as soon as possible.
