Subject: R1206013 Email Ruling Shortening Comment Period on SDG&E's Phase 2
Proposed Settlement

On March 27, 2014, San Diego Gas & Electric Company (SDG&E), The Office Of Ratepayer Advocates, The Utility Reform Network, The Utility Consumers' Action Network, The San Diego Consumers' Action Network, and The Coalition Of California Utility Employees (collectively referred to as "Settling Parties") filed a Joint Motion for Adoption of Settlement Agreement for Phase 2 Interim Residential Rate Design Changes for SDG&E. In that motion, the Settling Parties requested that the Commission shorten the period for comments contesting all or parts of the proposed settlement.

Pursuant to Rule 1.2 of the Commission's Rules of Practice and Procedure, that request is granted as follows:

(1) Comments contesting all or part of the Settlement Agreement are to be filed on April 7, 2014. This is the same day that Phase 2 Opening Briefs are due.

(2) Reply comments, if any, are to be filed no later April 14, 2014. This is the same day that Phase 2 Reply Briefs are due.

In addition, the terms of the settlement were presented at the Evidentiary Hearings on March 25, 2014. Parties at the hearings have already had the opportunity to ask questions of the witness panel

sponsoring the settlement. However, if any other party believes that an additional opportunity to brief the issues raised in SDG&E's proposal is necessary, the party should request additional briefing dates no later than April 8, 2014. If such a request is granted, the briefing dates would be: April 17, 2014 for Opening Briefs and April 21, 2014 for Reply Briefs.

The Docket Office shall formally file this Ruling.
