**CPUC TO HOLD PUBLIC PARTICIPATION HEARINGS  
THROUGHOUT STATE TO HEAR FROM CONSUMERS**

SAN FRANCISCO, April 18, 2014 - The California Public Utilities Commission (CPUC) will hold Public Participation Hearings throughout the state in the coming months on a number of issues in order to reach out to consumers and gain input on CPUC proceedings.

Public Participation Hearings allow the public to comment on utility cases that are before the CPUC. Comments from the public can help the CPUC reach an informed decision, and consumers are encouraged to attend.
