Pursuant to Section 9.2. of the QF/CHP Settlement Term Sheet (“Term Sheet”), SDG&E hereby provides notice that due to the recent termination of the Jasmin PPA (56MW) under its own terms, SDG&E will no longer meet its cumulative MW Targets A and B established by Term Sheet Section 5.1.2. Those Targets are 60 MW and 50 MW, respectively. SDG&E expects to rollover approximately 60 MW into its 3rd RFO in the Initial Program Period (solicitation expected in Q2-Q3 2015), although such amount could be significantly reduced as a result of pending negotiations.

Finally, SDG&E acknowledges that this notice should have been served on April 25, consistent with Term Sheet Section 9.2.2 (2). Because of an administrative oversight, this did not happen. SDG&E apologizes for the delay.
