Valerie,

When we talked by phone on April 3rd, you gave PG&E approval to restart demolition of the Kern project. At that time and in the follow-up email below, I requested confirmation of SED's decision and authorization to proceed by email or letter. PG&E has not yet received such confirmation. We have nevertheless proceeded to schedule the demolition work based on our verbal discussion.

There is a kick-off meeting scheduled with our contractors at the Bakersfield project site on April 30th. You and your team are invited to that meeting. Earlier today, I sent you the meeting invitation for this kick-off. Our schedule contemplates that mobilization and demolition will commence the week of May 5th.

Please contact me immediately if the Safety and Enforcement Division has any concerns with our plan to restart the demolition work at Kern. We will be notifying the local community in advance of restarting this work.

Thank you for your approval last week to move forward with the Kern demolition. Given your August 20, 2013 letter that directed PG&E to stop demolition, we would still like confirmation by email or letter that we may now proceed with demolition.

We are now working on developing the mobilization timeline with our contractors and experts. Currently, we are targeting the week of April 28th for the kick-off meeting, with demolition commencing the following week. While this timeline is still tentative, I wanted to let you know what we are contemplating so that you and your team have advance notice of our current schedule. I alerted our Project Manager, Anthony Haroian, to the fact that SED staff plan to be on site during the demolition and will probably want to participate in the kick-off meeting.
