Karen,

For our meeting on Monday, there are three open issues. They are as follow:

1. PG&E and MCE have agreed to put a footnote under the rate comparison table to state the rate comparison does not include PG&E's pending General Rate Case. We have not reach consensus on the wording of the footnote.

MCE's proposal: This rate comparison does not include PG&E's current General Rate Case request for \$1.28 billion in funding. For more information please visit <http://www.grc2014facts.com>

2. PG&E and MCE have agreed to change the first sentence in the footnote under the CO<sub>2</sub> Emissions table to read as follows: The CO<sub>2</sub> emission rates reflect emissions associated with PG&E's and MCE's respective energy supplies in 2012.

MCE is considering PG&E's request to remove the second sentence which reads as follows: For the purposes of this chart, renewable energy, hydroelectric and nuclear resources have been considered GHG free.

3. PG&E and MCE have a different calculation methodology for the CO<sub>2</sub> Emissions. MCE follows the protocols established by The Climate Registry and PG&E follows the protocols established by the California Air Resources Board. Specifically, there are differences in how the unbundled RECS from out of state are treated. At the meeting, both PG&E and MCE will go into further details to explain our positions.

Geof Syphers and Kelly Foley from Sonoma Clean Power will be joining us for the meeting.
