Your Honor and Parties,

Good morning. Currently, reply testimony is due Tuesday, May 20, and the evidentiary hearings are scheduled to start Monday, June 9. This gives parties less than three weeks to prepare for these hearings, including the Memorial Day holiday weekend. This is a very tight schedule for a broad, and very important proceeding.

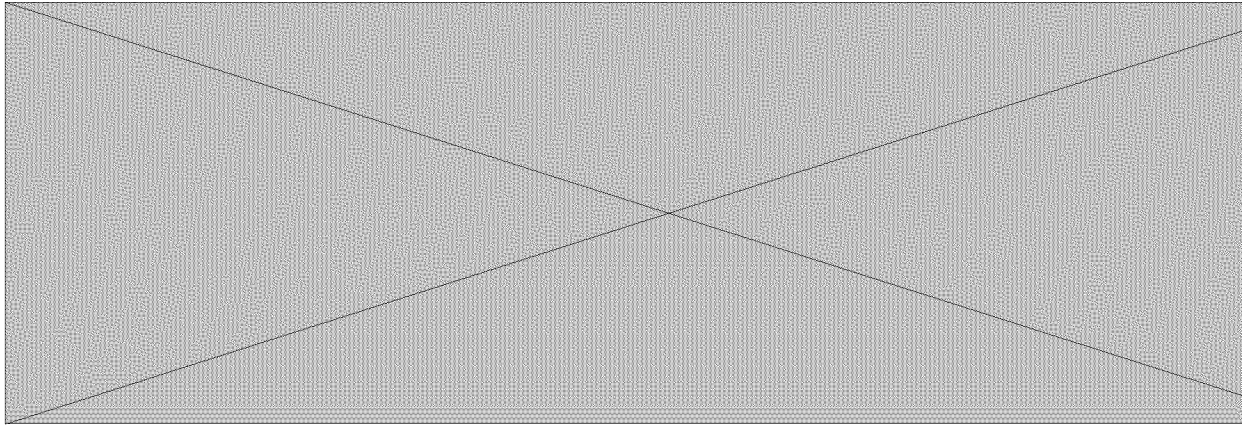
While CLECA sympathizes with the CAISO's need for more time, CLECA opposes the requested extension of the reply testimony date by full week, from May 20 to May 27. As CAISO states, and CLECA fully agrees, many parties served lengthy and technical opening testimony; reply testimony will likely be similarly voluminous. Parties will already be pressed to prepare adequately for the hearings, and an extension to May 27 would reduce the preparation time to less than two weeks. CLECA cannot support losing a full week of preparation time for the hearings set for the week of June 9.

CLECA does not, however, oppose the CAISO's secondary request for a more limited extension, to May 23, the Friday before Memorial Day weekend. Noting that Friday, May 23, is the start of a holiday weekend, should this more limited extension be granted, CLECA respectfully requests that all parties be directed to serve their reply testimony as soon as possible that day, and in no event later than the close of business.

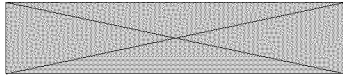
