Per ALJ McKinney's email ruling issued on May 15, 2014, PG&E is proposing the following tentative dates and locations for the Public Participation Hearings in Phase 1 of the Residential Rate OIR.

Suggested locations in PG&E service territory:

1. San Francisco at the CPUC
2. Fresno

Suggested date ranges:

1. September 22 – September 26
2. September 29 – October 1
3. October 9 – October 13

To avoid confusion and provide for adequate lead time for notice to customers, PG&E would prefer to hold the public participation hearings in the Residential Rate OIR after the public participation hearings in its Gas Transmission & Storage (GT&S) proceeding have concluded. The hearings in the GT&S case have not been scheduled yet, but are expected to occur in mid/late August and early September. PG&E also prefers not to have any hearings scheduled during the week the Phase 1 Rebuttal Testimony is served on October 8.

Please provide any comments or suggestions on these proposed dates and locations **by end of day, Thursday May 22nd**, so PG&E can respond back to the ALJs on Friday, May 23 as directed in the email ruling.
