DECLARATION OF DAVID PEFFER

I, David A. Peffer, declare and state that the following is based on my own personal knowledge, and if called upon as a witness I could and would competently testify thereto:

1. The Protect Our Communities Foundation (“POC”) is a California nonprofit corporation located in San Diego, California. POC is an active and regular participant in Commission proceedings impacting San Diego area utility ratepayers. Because of the significant cost and burden of traveling to the Commission in San Francisco, POC practices before the Commission by electronic means as much as possible, and is not often physically present at the Commission.

2. Since July 2013 I have represented the Protect Our Communities Foundation in Track 4 of the 2012 LTPP proceeding, R.12-03-014. Since at least September 29, 2013, I have been listed as the Protect Our Communities Foundation’s representative on the service list for R.12-03-014. POC has been an active party in Track 4 of R.12-03-014, and has participated in all aspects of the proceeding, including submitting comments on the Proposed Decision.

3. Since being added to the service list, I have received regular email service of filings in R.12-03-014.

4. I am not subscribed to any Commission digests or email lists beyond the official service lists for the Commission Proceedings to which POC is a party. POC relies on official service for notice of Commission Decisions.

5. The Protect Our Communities Foundation has received email service containing links to Commission documents and decisions in R.12-03-014 in the past. On February 11, 2014, I received official email service of ALJ Gamson's Proposed Decision for Track 4 of R.12-03-014. (Exhibit 1). On March 4, 2014, I received official email service of the Commission Decision D.14-02-040, which resolved Track 3 of the LTPP proceeding, R.12-03-014. (Exhibit 2).

6. To date, the Protect Our Communities Foundation has not received service of the Track 4 Final Decision D.14-03-004 in the form of an official hard copy of the Decision sent by mail.

7. To date, the Protect Our Communities Foundation has not received service of the Track 4 Final Decision D.14-03-004 in the form of an email to the service list for R.12-03-014 containing a full electronic copy of the Decision.

8. Prior to April 24, 2014, the Protect Our Communities Foundation had not received service of D.14-03-004 in the form of an email containing an internet link to a full electronic copy of the Decision.

9. To date, the Protect Our Communities Foundation has not received a hard-copy “Notice of Availability” document from the Commission for D.14-03-004.

10. I did not become aware of D.14-03-004 until April 22, 2014, when I came across the decision while reviewing the Docket Card for R.12-03-014.

11. On April 23, 2014, I sent an email to Shonta Bryant-Floyd, the Legal Support Supervisor for the ALJ Division (Star Unit) who had previously served D.14-02-040 to the service list for R.12-03-014, informing her that POC had not received official e-mail service of D.14-03-004 and asking when POC should expect service. (Exhibit 3).

12. On April 24, 2014, I received an email from CPUC employee Antonia Swansen containing a link to D.14-03-004 with no other information as to whether service had been effected. (Exhibit 4).

13. On April 25, 2014, I received an email from Shonta Bryant-Floyd responding to my repeated requests for a copy of the official service email for D.14-03-004, if such an email existed. Ms. Bryant-Floyd stated that “we unfortunately we did not have luck in finding the ‘Courtesy’ e-mail that Antonina sent on 3/14/14, however, you should have received the hardcopy of the Decision as you did provide a street address and zip. Hard Copies were mailed to parties on the date of issuance of 3/14/14.” (Exhibit 5).

14. After receipt of Ms. Bryant-Floyd’s email, I rechecked POC offices and case files and confirmed that POC never received a hard copy by mail of either the full Decision or the Notice

of Availability. On April 28, 2014, I responded to Ms. Bryant-Floyd's April 25, 2014 email, asking: "To clarify, by 'Hard Copy' do you mean a full official copy of the 171 page Decision and Attachments, or one of those one-page Notices of Availability?" Ms. Bryant-Floyd responded the same day, stating that by "Hard Copy" she was referring to the Notice of Availability. (Exhibit 6).

15. On April 25, 2014, Sierra Club attorney Matthew Vespa informed me that the Sierra Club has not received official email service of D.14-03-004.

16. On April 25, 2014, the attorney representing the California Environmental Justice Alliance, Shana Lazerow, informed me that she has no record of receiving electronic service of D.14-03-004.

17. On April 25, 2014, TURN attorney Marcel Hawiger informed me by email that neither he nor TURN attorney Matthew Friedman were able to locate any email providing TURN with electronic service of D.14-03-004.

18. On April 24, 2014 and April 25, 2014, ORA attorney Diana Lee informed me that she was unable to locate a copy of an email providing official electronic service of D.14-03-004.

19. Some of the parties that I contacted had been made aware of D.14-03-004 by other means, including by way of the Commission's "energy" digest, or by their presence during the Commission's March 13, 2014 meeting.

I declare under penalty of perjury under the laws of the state of California that the foregoing is true and correct. Executed this day, May 22, 2014, in San Diego, California.
