**Subject:** R.12-06-013: SDG&E Public Participation Hearings

ALJs McKinney and Halligan:

This e-mail is being transmitted pursuant to ALJ McKinney's May 15, 2014 Ruling, which provided the following direction:

*The utilities will work with the intervenors to create a list of suggested locations for Public Participation Hearings. The list is due on May 23, 2014. The list may include suggested dates in August or early September 2014. At the PHC, parties indicated that five Public Participation Hearings are necessary as follows:*

- *PG&E territory – 2*
- *SCE territory – 2*
- *SDG&E – 1*

*Additional suggested locations should be included if there is a critical need.*

Pursuant to the forgoing Ruling, on May 21, SDG&E informed the parties that it is available any time between August 1 and September 15, 2014, with the exception of August 26, to attend Public Participation Hearing in its service territory. SDG&E also indicated that, similar to SCE, it prefers not to have hearings scheduled between September 15 and October 8, 2014 with Intervenor Opening Testimony and Rebuttal Testimony due respectively on those dates. SDG&E recommended the following locations for this hearing:

- Al Bahr Shriners Building, located at 5440 Kearny Mesa Road in the Kearny Mesa area of San Diego; or
- Masonic Lodge, located at 1895 Camino Del Rio South in the Mission Valley area of San Diego.

Both locations are wheelchair accessible, convenient by bus or car, have ample parking, and have previously held Public Participation Hearings for other proceedings. SDG&E recommended that this Public Participation Hearing be noticed in the local newspapers and posted in SDG&E's business offices, similar to the noticing requirements for evidentiary hearings, and that 60 days prior to the hearing are necessary for noticing purposes and indicated that it will comply with all noticing required by the Commission.

Parties were asked to provide any comments or suggestions on these proposed dates and locations by end of day, Thursday May 22, 2014, so SDG&E could respond back to the ALJs on Friday, May 23 as directed in the May 15 email ruling.

The comments of parties on SDG&E's proposal are summarized below:

#### **ORA**

ORA recommends that both SCE and SDG&E choose dates post the intervenor testimony due date (September 15, 2014) so that the public would have the benefit to compare the intervenors' proposals in contrast to those of the IOUs when they attend the Public Hearings.

ORA especially objects to the choices that are close to intervenor testimony due date.

#### **Sierra Club**

I spoke with some of our San Diego members and they expressed a preference for Shriners due to its more central location.

## CALSEIA

CALSEIA is fine with these dates and locations. Thank you for coordinating.

## TURN

We have reviewed all the Public Participation Hearing (PPHs) dates and locations suggested by the utilities. TURN proposes changes to the dates and some additional suggestions for locations.

TURN is concerned about the potential overlap between the R.12-06-013 PPHs and important PPHs in other proceedings that may be scheduled in late August or early September. In order to allow consumers to attend PPHs scheduled in multiple proceedings, TURN proposes that the R.12-06-013 PPHs be scheduled after September 15. This recommendation is also consistent with ORA's proposal for dates after the deadline for intervenor testimony (September 15, 2014).

. . . For consumers located in San Diego, the Masonic Lodge is closer to low income communities, but in previous hearings consumers requested that the CPUC hold hearings at The Jacobs Center which has a 1200 seat multipurpose room which has been used for public hearings and other events. It is located near a trolley stop and a major freeway and is relatively central to communities south of Interstate 8. While there is a cost to use the facility, community members have been able to secure the site at a discounted rate.

We respectfully submit the following schedule of dates and locations based upon consumer input and past experience of locations that can generate a successful and diverse turnout.

However, based on the forgoing and consistent with direction in the ALJ Ruling to the effect that, "the list may include suggested dates in August or early September 2014," SDG&E recommends that the Public Hearing take place between August 1 and September 15, 2014 at one the following locations:

- ██████████ Al Bahr Shriners Building, located at 5440 Kearny Mesa Road in the Kearny Mesa area of San Diego; or
- ██████████ Masonic Lodge, located at 1895 Camino Del Rio South in the Mission Valley area of San Diego.

SDG&E appreciates the opportunity to work with intervenors to create a list of suggested locations as well as suggested dates in August or early September 2014 to conduct the SDG&E Public Participation Hearing.
