The plan is to have our customer impact representatives and our electric vegetation management manager for the area at the site when the work is conducted to address questions by customers.

There is not a moratorium in Oakland on electric vegetation management work. We did let the City and the neighborhood group know that we would need to prune in about 4 weeks.

> I wanted you to be aware of situation we had today at the park. In Electric Operations, we have an Electric Vegetation Management Program, which performs work under GO95 and has been involved in the discussions regarding the park. Separately, Electric Ops also has a Public Safety and Regulatory group (PS&R) that performs inspections for Maintenance and Construction for compliance with GO165. PS&R does request vegetation work directly to tree companies to address compliance with GO165, which is what happened today at the park. The crew was trimming an oak tree to address branches in contact with the guy wire and a branch that was growing within the climbing zone when they were approached by a customer that stated that PG&E has a moratorium on pruning in the area right now. After consulting with their management, the crew discontinued the work. We also received a call from the City stating that they had received complaints and were wondering why we were pruning when we had stated that we would not be doing so for the next two to four weeks. We will be calling the City tomorrow to explain what happened and to let them know that we will be better coordinated in this area going forward. While the crew needs to complete the GO165 required trimming, they are waiting to proceed.
