This email ruling (1) confirms that Exhibits SCE-03, SCE-04, SCE-05, SCE-06, and SCE-07 were admitted into the evidentiary record at the Phase 2 Evidentiary Hearing on March 25, 2014, and (2) for the record, corrects the Reporter's Transcript (R1206013_032514_Vol1 EH) regarding admission of these exhibits.
