Subject: R.12-06-013: PG&E public participation hearings

ALJ McKinney and ALJ Halligan,

Per your email ruling issued on May 15, 2014, PG&E is recommending the following potential dates and locations for the Public Participation Hearings in Phase 1 of the Residential Rate OIR.

Suggested locations in PG&E service territory:

1. San Francisco at the CPUC
2. Fresno

Suggested date ranges:

1. September 22 – September 26
2. September 29 – October 1
3. October 9 – October 13

We recognize that our suggested dates are somewhat later than what the other utilities may be proposing and what was discussed at the prehearing conference, but subsequent to the PHC, we have learned that PG&E's Gas Transmission & Storage (GT&S) public participation hearings are expected to occur in mid/late August and early September. PG&E would prefer that the public participation hearings in the RROIR be held after the GT&S hearings have concluded, in order to avoid potential public and customer confusion. PG&E also prefers not to have any hearings scheduled during the week the Phase 1 Rebuttal Testimony is served on October 8.

Below is the summary of feedback received from other parties:

1. ORA has no objections to PG&E's suggestions.
2. CforAT would prefer to have all the hearings for all utilities during the same time frame and to occur in August or early September
3. Vote Solar prefers not to have hearings during the week of September 22-26
4. CALSEIA prefers not to have hearings during the week of September 29-October 1
5. TURN's preferred dates are September 22-26
6. No parties had objections to the suggested locations. TURN suggested Fresno City Hall located at 2600 Fresno Street as the specific site in Fresno.

Based on this input, and subject to your preferences and availability, it appears that the week of October 9 – October 13 is the period with the most support and least concern among parties providing comments. Please let us know if you have any questions. Thank you.
